Mr. Dizard made a motion to set date and time of the Regular Meetings for the 4th Monday of each month at 7:00 p.m. Seconded by Mr. Meanor. Motion carried.

Mr. Dizard made a motion authorizing Township Officials' attendance at any Conference or Convention as permitted under the First Class Township Code. Seconded by Mr. Meanor. Motion carried.

Mr. Dizard made a motion to reappoint Patricia Babinsack, Tom Cjaka, Alvin Miller, Anthony Resnick and Robin Bergstrom to the Tree Committee for a two-year term. Seconded by Mr. Meanor. Motion carried.
